

Dear Candidate,□
Congratulations again on your candidacy for Ottawa City Council in the upcoming election. You should have already received a letter from the Ottawa Food Policy Council (OFPC) introducing itself as a potential resource and recommending how you might consider including food systems thinking into your campaign and in your future work as a Councillor. "Good Food," which we use interchangeably with "high-quality food," is defined as fresh, accessible, affordable, culturally relevant, minimally processed, as local as possible, and ecologically grown. As promised, we are contacting you once again to find out if and how you are planning on integrating Good Food in your electoral platform and as a priority once elected.
As outlined in our previous letter, there are many ways that the City of Ottawa can improve the local food system and increase resident access to Good Food. If elected, early in your term on City Council, you will participate in adding items to the legislative agendas of the Committees to which you have been appointed. At this time, we urge you to approach this crucial exercise with a food systems lens and bring forward the priorities below. A food system lens includes all aspects of the food cycle, from decisions that are made about food production, through to harvesting, processing, distribution, retail, preparation, food service, consumption, and disposal.
